Colorado (2021 Ballot)	Amendment 78  Legislative Authority for Spending State Money  Placed on the ballot by citizen initiative  Passes with 55 percent of the vote	Amendment 78 proposes amending the Colorado Constitution and the Colorado statutes to:  • prohibit state agencies from spending money received for a particular purpose (custodial money) without direct allocation by the state legislature; • require that custodial money be deposited into a newly created fund and that interest earned on money in the fund be transferred to the state's General Fund; and • require that the state legislature allocate any spending from the new fund each year following a public hearing.  What the votes mean:  • A "yes" vote on Amendment 78 requires that all state spending be allocated by the state legislature and that custodial money be deposited in and spent from a new fund. • A "no" vote on Amendment 78 allows state agencies to continue spending custodial money and certain other money without appropriation by the state legislature.
